#### **4.1 Description of first aid measures**

### **SECTION 7 - HANDLING AND STORAGE**

**7.1 Precautions for safe handling:** Use in a chemical fume hood, with air supplied by an independent system. Avoid inhalation, contact with eyes, skin and clothing.
